RE: EMPLOYEES' RETIREMENT CONTRIBUTION RATE INCREASE, EFFECTIVE JULY 1, 2014, FOR MEMBERS IN THE CALPERS CATEGORIES OF SAFETY, STATE PEACE OFFICERS FIREFIGHTERS, PATROL AND 2ND TIER; AND MEMBERS OF THE JUDGES' RETIREMENT SYSTEM II

SAFETY, STATE PEACE OFFICERS FIREFIGHTERS, 2nd TIER AND JUDGES

As part of the ongoing implementation of the Public Employees' Pension Reform Act of 2013 (PEPRA) a number of changes for certain employees are required to ensure their withholdings are consistent with the increased retirement contribution rates for state employees per Government Code Section 20683.2. Refer to the additional references as follows:

- The Department of Human Resources' (CalHR) Policy Memo #2014-01821, dated June 20, 2014
- CalPERS Judges' Retirement System letter, dated April 15, 2014, Employee Contribution Rate For Fiscal Year 2014-2015 For All JRS II New Members Subject To The Public Employees' Pension Reform Act 2013 (PEPRA)

PATROL

In accordance with Memorandum of Understanding with Bargaining Unit (BU) 5 Highway Patrolmen, the redirect of the 2% OPEB (Other Post-Employment Benefits) contributions to employees' CalPERS pension funds ended June 30, 2014 (June 2014 pay period). The ending of the redirect results in a 2% increase to the employees' retirement contribution. Refer to the additional reference as follows:

• Addendum to Bargaining Unit 5, California Association of Highway Patrolmen Memorandum of Understanding – Salary, dated July 3, 2013

Employment History (EH) Mass Update

On July 7, 2014, employees' EH records were updated, posting 505 - Account Code transactions to reflect the new retirement contribution rates effective July 1, 2014. A number of records were identified as exceptions to the mass update and, therefore, were excluded from the automated update process.

Note: The effective date of the 505 transactions for bi-weekly employees is July 14, 2014, the first day of the July 2014 pay period, as directed by CalHR.

Mass Update Exceptions

Exceptions to the mass update will be processed manually by PPSD, when possible. For example, employees with an EH record reflecting an out-of-sequence status (i.e., the effective date on the most current transaction was after July 1, 2014), will be processed manually.

PPSD is unable to update the EH records to reflect the new rates when the employee is off pay status (e.g., on a leave of absence, or an Appointment Expiration Date prior to July 1, 2014). These employees' Item 505 – Account Code field must be updated by the appointing agency once their appointment is extended or the employee returns to active pay status following a leave of absence. Although Item 505 is not a required field when returning an employee to pay status, the new account code **must** be entered on the Personnel Action Request (PAR) in order to reflect the new retirement rate on the employee's record. If the account code is not entered, the retirement contribution will be withheld at the incorrect rate and will require future adjustments.
