RE: AFFORDABLE CARE ACT COMPLIANCE REPORT AND SYSTEM UPDATES

In an effort to provide the most accurate ACA data to employees and the Internal Revenue Service (IRS), the State Controller's Office (SCO) has made updates to compliance reports and the ACA System (ACAS) to aid agencies in keying, reviewing and tracking employee data.

COMPLIANCE REPORT UPDATES

PDA2050F

The IRS does not accept invalid addresses through the annual reporting process. Effective September 1, 2018, SCO is updating compliance report PDA2050F to notify agencies and campuses of employee(s) without an address that the IRS will accept. For each employee listed on the report, please update the address record as appropriate. This report will be available on ViewDirect as indicated below.

PDA2050G

Effective September 1, 2018, SCO is updating compliance report PDA2050G to allow ACA Status Code 6A as an acceptable status code for District Agricultural Association 119-Day employees (employees with an * in the 7th character of the position number). Previously, the only acceptable status code for these employees was 2A. For each employee listed on the report, please update the ACA Status Code.
