- The Annual Reorganization letter will be released in May. All STD. 607 listings for reorganizations, effective July 1, 2025, must be received by Monday, June 9, 2025.
  - STD. 607 forms that are not received by the above dates may result in inaccuracies on the Schedule 8/7A, which may require extensive manual reconciliation during subsequent phases of the budgetary process. Please allow sufficient time for the Department of Finance approval, if required.
- Note: Do not submit any STD. 607forms that should not be reflected on the Schedule 8/7A before Tuesday, July 1, 2025.
