## Notice to Investigators

### Investigator DVD-ROM Re-Release Date: April 24, 2012

The State Controller's Office, Unclaimed Property Division, has made technical adjustments to the abandoned property investigator DVD-ROM that was originally released on March 13, 2012, and then re-released on March 28, 2012, in order to address the DVD's slow download speed and to make the search function more user-friendly. The DVD-ROM is updated through March 14, 2012, and contains listings of abandoned properties remitted to the State of California. If you have already purchased the March 28, 2012, DVD-ROM, a new one will be mailed to you. The enhanced DVD-ROM will be available for purchase beginning Tuesday, April 24, 2012, at the UPD office located at 10600 White Rock Road, Suite 141, Rancho Cordova, CA 95670 for walk-in orders or by mail using the address located on the order form.

This disc contains properties of all types. Cash properties only include those with a value of \$10.00 or more. Use of the DVD-ROM will require a computer with a DVD drive and Microsoft Access, RAM minimums of 128 MB for Windows XP, 512 MB for Windows Vista, and 1GB-2GB for Windows 7. The application does not support Macintosh/Apple applications.

The Estates File CD-ROM, released in November of 2011, is still available for purchase while supplies last. The disc contains updated information on estate properties through October 2011. An update of the Estates File CD-ROM is expected to be released in April of 2012.

You may order the Investigator DVD-ROM and/or Estates File CD-ROM by mailing the following completed order form with your order selection and payment. Please include a money order or cashier's check made payable to the California State Controller. **Cash and personal checks will not be accepted.**
